CHILDREN'S HOSPITAL PROGRAM OF 2008 2017 ANNUAL REPORT

PROGRAM OVERVIEW

On November 4, 2008, California voters passed Proposition 3 enabling the State of California to issue \$980 million in General Obligation bonds for the Children's Hospital Program. Under California Health and Safety Code, Sections 1179.50-1179.72, the purpose of the program is to improve the health and welfare of California's critically ill children, by providing a stable and ready source of funds for capital improvement projects for children's hospitals. The California Health Facilities Financing Authority (CHFFA) is responsible for administering the program.

Language in Proposition 3 makes thirteen children's hospitals in California eligible for funding and sets funding maximums for each hospital. Eight are private nonprofit hospitals and five are University of California hospitals. Grant awards for non-University of California children's hospitals are limited to \$98 million, less costs of issuance and administrative costs. Grant awards for University of California children's hospitals are limited to \$39.2 million, less costs of issuance and administrative costs. Costs of issuance are \$0.75 per \$1,000 of the authorized grant award and administrative costs are \$5.00 per \$1,000 of the authorized grant award.

In summary, the Children's Hospital Program of 2008 has fully funded six of the thirteen hospitals. The remaining children's hospitals have until 2018 to draw down their funds. In 2017, CHFFA awarded three grants and disbursed approximately \$24 million in grant funds to three children's hospitals (see summary table below).

Presently, four children's hospitals have open construction or equipment acquisition projects. Staff routinely monitors these projects through a variety of methods including site visits, emails, telephone calls, disbursement requests, news reports, and construction web cams.

A summary of grant disbursements made by CHFFA in 2017 is presented directly below. A detailed summary of the amounts allotted by statute, the amounts disbursed and grant funding remaining for future applications for each hospital follows.
