

**CHILDREN’S HOSPITAL PROGRAM OF 2018**  
**2023 ANNUAL REPORT**  
**(In accordance with Section 16724.4 of the Government Code)**

**PROGRAM OVERVIEW**

On November 6, 2018, California voters passed Proposition 4, enabling the State of California to issue \$1.5 billion in General Obligation bonds for the Children’s Hospital Program of 2018. Under Health and Safety Code sections 1179.81-1179.102, the purpose of the program is to improve the health and welfare of California’s critically ill children, by providing a stable and ready source of funds for capital improvement projects for children’s hospitals. The California Health Facilities Financing Authority (CHFFA) is responsible for administering the program.

Language in Proposition 4 identifies 13 children’s hospitals in California (referred to as Children’s Hospitals) and another approximately 160 public or private nonprofit hospitals that provide pediatric services for children eligible for the California Children’s Services (CCS) program (referred to as Eligible Hospitals) as eligible for funding. Proposition 4 allocated \$1.35 billion for the 13 eligible Children’s Hospitals and \$150 million for the Eligible Hospitals. The 13 Children’s Hospitals designated by statute are the same as the 13 hospitals that received grants under the first two Children’s Hospital Programs also administered by CHFFA and enacted by Proposition 61 in 2004 and Proposition 3 in 2008.

The 13 Children’s Hospitals consist of eight private nonprofit Children’s Hospitals and five University of California (UC) Children’s Hospitals. Grant awards for each private nonprofit Children’s Hospital was limited to \$135 million, less costs of issuance and administrative costs. Grant awards for each UC Children’s Hospital was limited to \$54 million, less costs of issuance and administrative costs. Grant awards for each Eligible Hospital was limited to \$15 million, less costs of issuance and administrative costs. Costs of issuance are \$0.75 per \$1,000 of the authorized grant award, and administrative costs are \$10.00 per \$1,000 of the authorized grant award.

The first funding round for the 13 Children’s Hospitals started on April 12, 2019 and will end on June 30, 2033, and each of the 13 Children’s Hospitals can submit an application for their full or partial allotted grant amount to fund eligible project(s) during this period.

Grants for Eligible Hospitals were awarded on a competitive basis during two funding rounds. The first funding round opened in April 2019 with an application submission deadline of March 30, 2020. For the first funding round, CHFFA received 12 applications and awarded grant funding to 11 applications, totaling \$127,749,462.80 on June 25, 2020. The second funding round opened in July 2020 with an application submission deadline of September 10, 2020. For the second funding round, CHFFA received four applications and awarded grant funding to all four applications, totaling \$21,472,919.63 on December 3, 2020. A remainder of \$851,032.39, which includes unencumbered funds as well as funds forfeited by Eligible Hospitals, is still available for a third funding round for Eligible Hospitals. CHFFA will determine at a later date when to open a third funding round.

A summary of all grant disbursements made by CHFFA in 2023 as well as a detailed summary of the Children’s Hospital Program of 2018, entailing information on amounts allotted by statute and regulations, the amounts disbursed, and any remaining funding per hospital, is provided.
