### Introduction

Pursuant to California Education Code (EC) 47614.5(h), the California School Finance Authority (CSFA or Authority) is required to present fund details of the Charter School Facility Grant Program (Program) each fiscal year. Given the nature of the Program's funding cycle, CSFA is reporting on the Program updates and highlights for the 2019-20 Funding Round as disbursements for each Funding Round are often made across fiscal years.

#### Program Background

Senate Bill 740, authored by Senator Jack O'Connell in 2002, established the Charter School Facility Grant Program (Program). Given that Senate Bill 740 created the Program, it is commonly referred to as the "SB740 Program," as well as the Charter School Facility Grant Program. From its enactment in 2002 through 2012-13, the California Department of Education (CDE) administered the Program. In the Governor's 2013-14 Budget, the Program's administration was transferred from CDE to the California School Finance Authority (CSFA). The Program provides grants to offset annual on-going facility costs for charter schools serving a high percentage of students eligible for free or reduced-price meals (FRPM) or for charter schools located within a public elementary school boundary that meets the FRPM criteria.

Prior to the 2016-17 Funding Round, the Program was typically undersubscribed, which resulted in the Authority not awarding the entire annual apportionment. Subsequently, the California Department of Finance (DOF) implemented a significant programmatic change, and reduced the FRPM program eligibility threshold from 70% to 55%. Since this change went into effect, the number of Program applicants, along with the percentage of funding disbursed, has steadily risen. The chart below provides historical information related to Program apportionments, amounts awarded to schools, the number of applicants as well as the percentage of funding disbursed to schools.

## **Regulation Changes**

Though initiated during the 2018-19 Funding Round, the Office of Administrative Law reviewed and approved permanent regulations in April 2020. Five sections were amended including the following: Sections 101710.2 – Definitions; 10170.3 – Eligible Applicant; 10170.4 – Eligible Cost; 10170.5 – Application Submission; and 10170.6 – Content of Application. The major changes were related to "good standing" requirements, the establishment of a Second Application period, documentation deadlines, and multi-year use of appraisals.

For "good standing", the updates to the regulations better clarify the standards for good standing confirmation, updates to the Good Standing Confirmation Form (GSCF), and provides remedies for applicants lacking a good standing confirmation. The GSCF was updated to prevent penalizing applicants for a lack of correspondence from their authorizer. GSCF that are not returned are assumed to meet the standard of good standing.


Newly opened schools were originally given the ability to apply through October 15 of each year, however this method required the Authority to provide open access to the general application, which allowed for late applications. An annual opening date of September 10 was established, and October 15 is still used as the close of the second application period. A 60-day deadline was established for all requested documentation and failure to comply may result in a partial or total loss of award funds. Changes to the appraisal process allowed for appraisals to be valid for three fiscal years when applicable. This change was implemented to minimize costs for schools while keeping an important oversight mechanism.

Due to concerns over the effects of the pandemic, staff submitted emergency regulations to the Office of Administrative Law for consideration in June 2020 and these were approved in October 2020, going into effect for the 2020-21 Funding Round. Previous language blocked late application and late facility invoice expenditure reports for submission as well as any appeal rights. The revised regulations removed language to allow the submission of late application and late facility invoice expenditure reports for consideration. This change allowed the Authority to work with schools that had administrative challenges with the changes brought on through the pandemic. These emergency regulations expired on August 28, 2021.

## 2019-20 Program Award Breakdown

In the 2019-20 Funding Round, the Authority awarded funds to 426 of the 437 eligible awardees. There were 11 of the 426 schools that did not have eligible rent or lease costs and therefore did not receive any funding due to oversubscription (discussed in detail in section "2019-20 Over-subscription" below). There were 17 additional applicants deemed ineligible; of these schools, 10, were ineligible due to FRPM below 55% and all 10 lacked admission preference. Five applicants were ineligible due to expired charter petitions, one applicant was ineligible due to a lack of good standing and the remaining ineligible applicants did not clear vetting for conflicts of interest. Five of the 17 ineligible schools had two factors causing ineligibility though all were ineligible due to not meeting the FRPM threshold.

A majority of applicants, 359 or 82%, had a pupil population with an FRPM percentage of at least 55%. Only 18%, or 77 applicants, relied on a local elementary school's FRPM percentage to receive funding. This is an increase from 2018-19, as 335 applicants, or 81%, had a pupil population with a percentage of at least 55%, and 80 applicants, or 19%, relied on a local elementary schools FRPM percentage to receive funding.



The average award would have been \$321,417.12 if the Authority had the funding to provide 100% of lease/rent based awards. This is a 24 percent increase for the lease/rent based awards issued in 2018-19 and this is a 7 percent decrease in total award from 2018-19 - when total other costs were included.

Due to the oversubscription, the Authority pro-rated lease/rent awards at 96%, which resulted in an average award amount of \$308,560.44. This is a 19% increase from lease/rent based awards in 2018-19, and about a 2% increase with pro-rated other costs, i.e. the type of awards sent out in 2018-19.

There was also a shift in award caps; awards are either 75% of reimbursable rent amounts or the average daily attendance (ADA) multiplied by \$1,184, whichever is less. In 2019-20, 121 applicant's awards were capped by their ADA, this is a 44% decrease from 2018-19's total applications of 216. Conversely, rent/lease capped awards rose in 2019-20 to 315, a 58% increase from 2018-19's total of 199. This is undoubtedly due to the oversubscription and inability to pay for other costs in 2019-20. When other costs are factored out in 2018-19, the cap ratio is very similar to 2019-20 with 111 schools capped at ADA and 304 capped at rent/lease costs.

#### Foster Youth and Homeless

As the Program is designed to provide funding to schools serving socioeconomically disadvantaged students, many of the schools in the program serve foster youth and pupils considered homeless. In 2019-20, there were approximately 662,116 students enrolled in grades K-12 in public schools. Of those 662,116 students, 2,501 were estimated to be foster youth and roughly 10,998 were considered homeless. In 2019-20, SB740 awardees served 32.0% of all foster youth enrolled, these 800 students make up 0.4% of all students enrolled with SB740 awardees, which is similar to the percentage enrolled statewide, again a little under 0.4%.

The Program also serves a sizeable portion of the pupils considered homeless. In 2019-20 SB740 awardees serves around 2,875 students which is 26.1% of the approximately 10,998 pupils considered

homeless enrolled across the state. The 2,875 students represent 1.4% of total enrollment of SB740 awardees and is also comparable to the state's percentage of 1.7%.

The majority of awardees serve a percentage of foster youths and/or pupils considered homeless at about 83.3%, or about 355 of the 426 awardees. The total award for these 355 awardees is nearly \$115,900,000, which is 84.7% of the Program's total apportionment. The average percentage of foster youths and/or pupils considered homeless for SB740 awardees is 2.4%, with the highest being 44.6%, 16 awardees also serve a percentage greater than 10%.

#### **English Learners**

More than 15% of all students, or about 100,569, enrolled in CA public schools are considered English Learners ("EL students"). In 2019-20 SB740 awardees served 46.4% of the state's EL students enrolled in public schools with an approximate total of 46,650. These students represent 23.1% of all students enrolled with awardees, which is more than 15.2% at the state level. In fact, awardees enrolled 46.4% of all EL students attending CA public schools.


The vast majority of awardees serve a percentage of EL students at about 98.6% or 420 of the 426 awardees. The total award for these 426 awardees is nearly \$134,100,000, which is 98.0% of the Program's total apportionment. The average percentage of EL students for SB740 awardees is 22.5%, with the highest being 90.3%. Thirty-five awardees also serve a percentage of at least 50%.


## Funding per County


SB740 funds numerous schools in a majority of California counties; in 2019-20, SB740 funded 676 different facilities operated by 426 schools serving more than 163,000 students. Of the 58 counties in California, SB740 awardees are located in 35 counties. The average county has 12 awardees with 19 facilities, with an ADA of approximately 4,675, and the average total funding per county is \$3,843,781.44. The average awardee per county received about \$245,387 in funds and \$176,193 per facility. Lastly, the average award per student is roughly \$752, lower than the program ADA maximum of \$1,184.

Los Angeles County received the greatest total of awarded funds at \$64,319,288.15; had the largest ADA with 75,273.85; most awardees with 185 awardees; and most facilities with 259 facilities. Mono, Inyo, San Francisco, and Trinity Counties have the highest average of dollar amount per student at \$1,136.64. Kern County has the high average award per awardee at \$693,752.62 for five awardees. Kern also has the highest average award per facility at \$693,752.62 for five facilities.





## Funding per Region



## Facilities per Region



Even in the regional breakdown Los Angeles County, Region 8, has the highest amount of awarded funds at \$64,319,288.15, ADA of 75,273.85, with 85 awardees, in 259 facilities. Region 8 has the highest average award per facility at \$248,337.02. Region 6 has the highest average dollar amount per student at \$936.96 and has two of the four highest per student average counties and also has the highest award amount per awardee.

## 2019-20 Over-subscription

For the first time under CSFA's administration, SB740 was oversubscribed to the point where rent/lease-based awards left no pro-rated funds available for other facility related costs. During the 2018-19 funding round around 277 applicants submitted other costs, requesting a total of \$37,362,321 or about \$90,685 per applicant. A majority of these applicants, 272, are also applicants for 2019-20 Funding Round and were not able to submit other costs due to the oversubscription.

Oversubscription led to additional funding delays as all award amounts are interconnected. Any change in awards over \$100 results in numerous, if not all, award amounts changing. Staff provided a third disbursement, which was pro-rated at 87.5% - that is the highest pro-ration possible. This allowed staff to provide a vast majority of applicants' awards while still verifying information and amounts from a select group of schools. The 2019-20 Funding Round concluded with a pro-rata of 96% for the fourth disbursement. There were overpayments due to ADA changes and miscalculations; these miscalculations were related to schools that have

some incorrect ADA totals as provided by CDE. Once these funds are collected, staff will provide a final disbursement to eligible applicants.

## Summary

The 2019-20 Funding Round presented many first time challenges. The challenge with the greatest concern was oversubscription causing the inability to fully fund lease/rent. This was also compounded by the COVID-19 pandemic and its effects from March 2020 onward.

Oversubscription, per staff projections, has been and will be an issue going forward as long as funding remains below lease projections. The Program was oversubscribed under the Department of Education's administration, and since 2013, when the Program was transferred to the Authority's administration, funding levels have allowed for full lease/rent costs. Oversubscription's main effect is the interconnectivity of awards. Best practice is for the Authority to ensure all awardees receive the same percentage of their eligible award amounts. In previous rounds, the Authority had the ability to authorize all awards that were already capped at their ADA levels, as well as schools with other costs, while holding back funds for any awards related to applicants appealing and/or working on eligibility requirements.

This is not the case for the 2019-20 Funding Round, all final awards must be authorized at the same time to ensure all awardees receive the same percentage of lease costs. Staff determined pro-rata estimates to find the highest possible percent to provide a disbursement. Staff and management provided these interim disbursements considering the fiscal impacts of the pandemic, both realized and projected. These disbursements provided 87.5% of the eligible award amount to each awardee; the highest percentage staff calculated to ensure no possibility of mass overpayment. This will likely be a consideration for all future rounds that are oversubscribed and have to pro-rate lease costs. The difference is that staff is able to plan ahead with the experience of the 2019-20 Funding Round.

Not all challenges negatively affect the Authority. Typically, there is a substantial amount of staff time spent verifying other costs and since there were no funds for other costs, staff was able to complete the 2019-20 Funding Round without the need for additional review. The planned end of the Funding Round is typically 30 days after the end of the associated fiscal year, this is prescribed by Education Code Section 47614.5(c)(4)(C), with the caveat of having "the data and documentation needed to compute the charter school's total annual entitlement". In reality, most Funding Rounds finish months later. The difference between previous rounds and the 2019-20

Funding Round is lease/rent based awards in the previous rounds could be provided once their respective True-Up reviews were completed. Typically, the only awards remaining in previous rounds have been based on appeals or related to disputes. In 2019-20, all awards were held back due to oversubscription as all awards were interconnected since the Funding Round was oversubscribed.

As mentioned earlier, the COVID-19 pandemic compounded all these issues. The Authority began emergency telework in March 2020. This change initially affected the collaboration and the speed of communication during the transition. Schools and charter management operators were also experiencing these same issues and many schools and operators were not equipped for a sudden move to telework and virtual instruction. These changes led to administrative strain on both Authority staff and applicants/awardees.

In conclusion, the 2019-20 Funding Round provided new challenges that CSFA used to improve efficiency and transparency within the Program. As staff works through the 2020-21 and 2021-22 Funding Rounds, the lessons learned are being implemented and the Authority is ahead of schedule on the 2020-21 Funding Round.
