POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Shower of the State Treasurer's Office presented the Portfolio Summary Report as of March 31, 2024. The total portfolio amount was \$156.474 billion, the effective yield was 4.215%, and the average life was 226 days. The amount of loans approved was \$350 million with a disbursed amount of \$262 million. The total deposit amount for the Local Agency Investment Fund was \$21.033 billion with 2,346 participants.

Ms. Andrea Paval of the State Treasurer's Office Centralized Treasury and Securities Management Division presented a summary of receipt changes in the portfolio for the ten-week-period of April 15, 2024 through June 21, 2024. The anticipated receipts total \$97.687 billion.

Mr. Peter Handal of the State Controller's Office Cash Management Bureau, State Accounting and Reporting Division presented the major disbursements anticipated for the ten-week period. The forecasted disbursements total \$93.711 billion.

Mr. Shower then presented Designation No. 1898.
