INTRODUCTION

Constitutional and statutory provisions require voters to authorize general obligation (GO) bonds issued by state and local governments. For bonds issued by the state, the authorization must be made through a statewide election. Local bonds must be approved by voters within the jurisdiction authorizing the bond. The state and local governments must also seek voter approval for levies of certain revenue exactions and taxes. For both state and local measures, the voter approval threshold depends on the type and purpose of the bond or tax (see Figure 1).

After each statewide election, the California Debt and Investment Advisory Commission (CDIAC) publishes a statistical summary and review of bond and tax measures appearing on state and local ballots. This report, the 30th in the series, summarizes the results of bond and tax measures on the June 7, 2016 Primary Election ballot. This report also contains appendices which summarize the measures by county, region, type of tax and purpose.

JUNE 2016 PRIMARY ELECTION RESULTS

SUMMARY

- *Total measures* – Voters considered 89 local fiscal measures. One local measure contained a special tax and GO bond combination. (Figure 2).
- *Approved measures* – Voters approved 70 (77.8 percent) of the measures: 46 local GO bond measures, 14 special tax measures and 10 general tax measures.
- *Passage rates* – GO bond measures received the greatest support from voters with a 90.2 percent approval rate. (Figure 2).

GENERAL OBLIGATION BOND MEASURES

- *Strong support for GO bond measures* – Voters approved 90 percent of these measures.
- *Volume of approved measures* – Voters approved approximately \$3.5 billion in GO bond measures.
- *K-12 educational focus* – 82.0 percent of the GO bond measures were for K-12 education (Figure 4).
- *Strong support for K-12 educational GO bonds* – Voters approved 90.2 percent (approximately \$2.7 billion) of K-12 education GO bond measures.
- *Strong support for community college GO bonds* – Voters approved 83.3 percent (approximately \$2.8 billion) on community college GO bond measures.

TAX MEASURES

- *Support for tax measures* – Voters approved 62.5 percent of tax measures (Figure 5).
- *Support for general tax measures* – General tax measures were supported (76.9 percent passage rate).
- *Majority vs. two-thirds voting requirement* – The general tax measures only needed a majority of the vote to pass. If these measures had a two-thirds voting requirement, only 28.6 percent would have passed. In contrast, special tax measures, which require two-thirds voter approval to pass, were less supported (55.6 percent passage rate). If these measures required a majority vote, 88.9 percent of the measures would have passed.
- *Purpose of taxes* – Most of the tax measures were special taxes for various purposes, such as fire, police protection/emergency medical and K-12 school facilities. The remaining measures were for other purposes and capital improvements (Figure 6).

RESULTS BY REGION

The election results are divided into five regions: Bay Area, Central Valley, Los Angeles, San Diego/Inland Empire, and Other (Figure 7).

- *Approved Measures* – Bay Area Region voters were presented with the most measures (35) and they approved the most measures (32). San Diego/Inland Empire voters approved the least measures (1).

- *Passage Rates* – The Bay Area Region also had the highest passage for GO bond and tax measures (91.4 percent). The San Diego/Inland Empire had the lowest passage rate (33.3 percent).

Figure 8 shows the number and percentage of measures that were approved by region.

COMPARISON OF THE 2014 AND 2016 PRIMARY ELECTIONS

- *Comparative passage rates* – The passage rate of bond and tax measures during the 2016 Primary election (77.5 percent) was the same as the 2014 Primary Election passage rate (77.5 percent).
- *Comparative number of approved measures* – The number of approved measures (69) in 2016 was the same as approved measures (69) in 2014.
- *General government measure passage rates* – General government measures had a lower passage rate in 2016 (72.7 percent) than 2014 (100 percent).
- *Special tax measure passage rates* – The passage rate for special tax measures was lower in 2016 (53.89 percent) than 2014 (72.4 percent).
- *Regional passage rates* – Excluding the "Multiple" region category, in the 2016 and 2014 Primary Elections, the Bay Area region had the highest passage rates (91.4 percent and 90.9 percent, respectively).
- *Passage rates by purpose* – In 2016, the passage rates for education was the highest (88 percent). In 2014, capital improvements and general government measures had the highest passage rate (100 percent).

- *Comparative number of proposed local measures* – In both elections, the highest percentage of proposed local measures was for educational use. The lowest percentage of proposed local measures was for capital improvements in both elections.

Figure 9 provides a summary of the passage requirements for the bond and tax measures appearing on the 2014 Primary Election and the 2016 Primary Election ballots.

Figure 10 provides a summary of the types of bond and tax measures on the primary election ballots.

A summary of votes by regions is provided in Figure 11.

Figure 12 summarizes the types of projects appearing on the Primary Election ballots. Projects that comprise the miscellaneous category include the following: abandoned vehicle program, charter amendment for taxes, fees, and bonds, community center modernization, lake maintenance, library services, open space, parks/park and recreation facilities, trails and natural space, and veteran's housing.

SUMMARY

The passage rate of bond and tax measures for the 2014 Primary Election and the 2016 Primary Election were the same, 77.5 percent. However, there were more general tax and GO bond measures approved in the 2016 Primary Election. In the 2014 and the 2016 elections, general

government measures received significant voter approval. In addition, for both elections, the highest percentage of proposed local measures was for educational use, and the lowest percentage of proposed local measures was for capital improvements.
