Friday, February 20, 2015	Staff Evaluations approved by ED [35 calendar days after application deadline.]
Friday, February 20, 2015 [Sec. 5036 requires posting to be at least 25 calendar days before meeting date.]	<b>Preliminary Recommendations posted.</b> [26 calendar days before meeting date.]
Friday, February 27, 2015 [Sec. 5037 requires appeals within 5 business days of posting.]	Appeals to preliminary recommendations due. [3 business days after preliminary posting]
Wednesday, March 4, 2015	Preliminary Appeals resolved and responses mailed. [3 business days before final posting]
Friday, February 27 – Thursday, March 5, 2015	Executive Director pre-posting briefing with State Treasurer. [5 business days before final posting.]
Friday, March 6, 2015	Meeting Agenda e-mailed and posted to Web. [12 calendar days before meeting date.]
Friday, March 6, 2015 [Sec. 5038 requires posting to be at least 10 calendar days before meeting date.]	<b>Final Recommendations posted.</b> [7 business days after preliminary appeals deadline.] [12 calendar days before meeting date.]
Wednesday, March 11, 2015 [Sec. 5038 requires appeals to be at least 5 business days before meeting date.]	Appeals to final recommendations due. [5 business days before meeting date.]
Wednesday, March 11, 2015	Meeting binders delivered to members and staff. [5 business days before meeting date.]
<b>Wednesday, March 18, 2015</b>	<b>Allocation Meeting.</b> [60 calendar days after application deadline.]
