## AMENDED RESOLUTION NO. 23-51

## APPROVAL OF FINANCIAL SOUNDNESS DETERMINATION FOR GRIFFIN TECHNOLOGY ACADEMIES ON BEHALF OF MIT ACADEMY FOR FINAL APPORTIONMENT THROUGH THE CHARTER SCHOOL FACILITIES PROGRAM

**WHEREAS**, the Charter School Facilities Program (Program) was established for the purpose of providing charter schools with funding to construct new facilities and rehabilitate existing district facilities; and

**WHEREAS**, modeled after the State's School Facilities Program, the Program funds 50 percent of project costs as a grant from the State, and 50 percent as a loan or lump sum, which the charter school or obligor is responsible for repaying to the Program; and

**WHEREAS**, the California School Finance Authority (Authority) and the State Allocation Board (Board), staffed by the Office of Public School Construction, are designated to jointly administer the Program; and

**WHEREAS**, the Authority is authorized by Education Code section 17078.57 to determine whether applicants to the Program are financially sound for purposes of the Program at the time of Preliminary, Advance, and Final Apportionment; and

**WHEREAS**, the Authority is required by section 10154 of Program regulations to conduct a review of Griffin Technology Academies (GTA) financial soundness on behalf of MIT Academy (MA) for purposes of a Final Apportionment; and

<u>WHEREAS</u>, the MIT's project, as described in staff's summary, is located at 1 and 2 Positive Place in Vallejo, California; and

**WHEREAS**, this determination of financial soundness will be provided to the Office of Public School Construction as it recommends to the State Allocation Board approval of a Final Apportionment to GTA on behalf of MA in the amount of \$46,802,406 for its New Construction and Rehabilitation project; and

**WHEREAS**, GTA will fulfill the project's local matching share obligation by accepting a 30-year loan term in the amount of \$23,401,203; and

**WHEREAS**, this determination of financial soundness is contingent upon there being no material legal, financial, or operational changes between the date of this resolution and GTA's receipt of apportionment on behalf of MA.

**NOW, THEREFORE, BE IT RESOLVED** by the California School Finance Authority as follows:

**Section 1**. That GTA has demonstrated its financial soundness for purposes of Final Apportionment on behalf of MA.

**Section 2**. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to notify the State Allocation Board and the Office of Public School Construction, and provide supporting documentation, that GTA has maintained its financial soundness for purposes of the Program and for its request for final release of funds on behalf of MA.

<u>Section 3.</u> The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to execute the Program Agreements between the State, Vallejo City Unified, and GTA.

**Section 4.** This resolution shall take effect immediately upon its approval and be in effect for twelve months from the date of adoption.

Section 5. All actions heretofore taken by the officers and employees of CSFA with respect to the execution and performance of the Program Agreements are hereby approved, confirmed, and ratified.
