POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Shower of the State Treasurer's Office presented the Portfolio Summary Report as of April 30, 2024. The total portfolio amount was \$171.468 billion, the effective yield was 4.317%, and the average life was 227 days. The amount of loans approved was \$350 million with a disbursed amount of \$268 million. The total deposit amount for the Local Agency Investment Fund was \$21.586 billion with 2,346 participants.

SURPLUS MONEY DECLARATION AND REDUCTION
