POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Shower of the State Treasurer's Office presented the Portfolio Summary Report as of July 31, 2024. The total portfolio amount was \$170.784 billion, the effective yield was 4.586%, and the average life was 220 days. The amount of loans approved was \$418 million with a disbursed amount of \$283 million. The total deposit amount for the Local Agency Investment Fund was \$20.305 billion with 2,341 participants.

Ms. Andrea Paval of the State Treasurer's Office Centralized Treasury and Securities Management Division presented a summary of receipt changes in the portfolio for the period of August 19, 2024 through October 18, 2024. The anticipated receipts total \$68.544 billion.

Mr. Jerry McClain of the State Controller's Office Cash Management Bureau, State Accounting and Reporting Division presented the major disbursements anticipated for the ten-week period. The forecasted disbursements total \$85.807 billion.

Mr. Shower then presented Designation No. 1902.
