POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Shower of the State Treasurer's Office presented the Portfolio Summary Report as of October 31, 2024. The total portfolio amount was \$155.920 billion, the effective yield was 4.506%, and the average life was 257 days. The amount of loans approved was \$194 million with a disbursed amount of \$85 million. The total deposit amount for the Local Agency Investment Fund was \$19.518 billion with 2,337 participants.

Mr. Shower then presented Designation No. 1905.

Mr. Sheldon asked for public comments; there were none. Ms. Perrault moved to approve Designation No. 1905. Upon a second by Mr. Oppenheim, the motion passed 3-0 with the following votes: Mr. Sheldon: yes; Mr. Oppenheim: yes; Ms. Perrault: yes.

SURPLUS MONEY DECLARATION AND REDUCTION

Mr. Shower presented the changes in the Surplus Money Investment Fund for the period October 1, 2024, through October 31, 2024. The Declaration of Surplus Money was in the amount of \$17.881 billion and the Reduction of Surplus Money was in the amount of \$17.741 billion.

Mr. Sheldon asked for public comments; there were none. Mr. Oppenheim moved to approve the Surplus Money Declaration and Reduction. Upon a second by Ms. Perrault, the motion passed 3-0 with the following votes: Mr. Sheldon: yes; Mr. Oppenheim: yes; Ms. Perrault: yes.

1. Fairway Finance Company, LLC

Ms. Paine noted that the commercial paper program is highly rated by S&P and Moody's. She also noted that adding the issuer to the list of approved PMIA investments would provide additional diversity in prime, short-term investment options for the Pooled Money Investment Account.

Mr. Sheldon added that ABCP investments represent a small amount of the PMIA and are short dated. He noted that Fairway and BMO carry high ratings and gave his support for adding the new investment.

Mr. Sheldon asked for public comments; there were none. Ms. Perrault moved to approve the proposed commercial paper issuer. Upon a second by Mr. Oppenheim, the motion passed 3-0 with the following votes: Mr. Sheldon: yes, Mr. Oppenheim: yes, Ms. Perrault: yes.
